Catalog Description: Advanced exploration of photography with emphasis on independent development of technique, composition and style. Six studio hours per week. Prerequisite(s): ART 281 or ART 382.

Course Objectives

In this advanced photography course, the student will: - work independently to produce conceptually related series of prints. - master photography technique and medium. - master discipline by working independent of assignments. - produce and present a cohesive body of work for exhibition. - produce and present a cohesive body of work for portfolio. - master self-critique and discussion/defense of their work. - gain a greater understanding of conceptual basis, historical contemporary photography.

Students will be evaluated (graded) through a combination of assignments, attendance, and participation. Full participation in all aspects of the class including critiques will be graded. Additionally, because this is an art class, students will be evaluated on creativity and their ability to produce work. This means that if you make a considerable effort, the instructor will take your labor into account, though this does not guarantee an "A." For maximum success, concern yourself less with your grade, and focus on investing yourself into the process of photography and art making.

General Observations on the Letter Grading System:

In general, students who receive an A, B, C, D, or F grade will fit into the following profiles.

A Grade Those students who attend class regularly and fulfill all the requirements of the course demonstrating exceptional effort and use the framework of the course as a vehicle for outstanding achievement in a way that transcends the assignments. This includes their exceptional ability to grasp concepts, techniques and materials presented in the course in a way that exceeds mere competency and produces work that demonstrates creative/imaginative use of the material presented in class. Often this student will do much more work than is specifically required or does the required assignments with a distinctive and original approach which indicates; 1) mastery of techniques presented, 2) sound design skills creatively applied and 3) professional attitudes toward their word, including proper presentation.

B Grade Those students who attend class regularly, do all the work in a satisfactory manner, and show the ability to use concepts, techniques and materials in a fashion that goes beyond mere competency and creates a body of quality personal and creative work based upon the course material. Sometimes this student will do more than is required and demonstrates some originality in solving design problems and managing the techniques creatively. Professionalism is demonstrated by good attendance and through work presented with reasonable skill. Students who show impressive and significant grown over the semester will often receive a B grade.

C Grade Does no more and no less than is necessary to meet the requirements of the course. Work is adequate without being exceptional, gives little evidence that the ideas and techniques presented in the course were used in an imaginative or creative fashion. Has not adopted a professional attitude toward the work and attendance was only adequate and presentation lacked quality craftsmanship.

D Grade Does not meet even the minimum course requirements or does not finish work. Frequently misses class and/or is often late, and has been absent at critiques. Class behavior is unsatisfactory and demonstrates the lack of desire to learn. Work completed or attempted gives little evidence of attention to details in technique or ideation and is poorly presented at critiques.

F Grade Similar grade to a D grade except the degree or any one or all of the listed factors make the student's ability to fulfill the requirements of the course impossible. Student does not come to meeting the course requirements. Attendance is poor and has missed several critiques. Fails to develop professional attitude to learning and their work in regards to quality and quantity produced.

Assignments and Descriptions and Tentative Due Dates:

Techniques:

In this class, we will also focus briefly on 2 techniques (in part due to missed spring content)

Large Format Photography Wet Plate Collodion

Class Discussion:

Students will choose one/two week(s) to lead the discussion on both the Robertson/McDaniel and the Cotton texts. Your task will be to prepare well, ask thoughtful questions and to draw your fellow students in quality discussion on the materials. You are encouraged to pull in other relevant sources (videos, works from the MSU art collection, other artists, etc.) and other contemporary or historical artists

beyond the readings (I am happy to assist you in finding those materials). You may create additional assignments and/or reading questions ahead of time for your students. $(10pts \times 2)$

Reading Notes:

Note taking in class and while reading not only helps reading comprehension, but aids in recall and further conversation. For each chapter you will turn in a set of notes on the assigned readings that exhibit completion of reading, as well as other ideas to develop. Recording of quotations and page numbers are especially helpful for our discussions. 1pt each week (11 total)

Theme Portfolios:

Two portfolios will be based on the themes of interest from the Robertson & McDaniel text.

Two weeks prior to the project due date, you will present a well-developed portfolio proposal. You will complete the Project Portfolio Form. In class, you will present your ideas, image previews, any work you have shot, images of other photographers or artwork that you will use as inspiration etc. and elicit feedback from your fellow students.

Process: Open - You may do digital, film, alt. process etc.

Additionally, you will write a 2 page (minimum) summary paper that addresses the work and how it connects to the chosen theme as presented in Robertson/McDaniel. This will be an opportunity to express your photographic work in formal academic writing. In this paper, I will be looking for:

- a clear summary/definition of your chosen theme (30%)
- where does it resonate and diverge from the texts?
- how this body of work fits into contemporary photography (20%)
- what makes this contemporary photography?
- from whom/what does your work draw inspiration?
- how you have chosen to express these ideas/concepts through imagery and final form (50%)

You will be graded on quality of product, creative potential and solutions, theoretical connections between readings and created work, and quality of writing. Each portfolio is worth 10 points (1pt Summary Paper, 9 pts Portfolio Images)

Final Portfolio:

For the final portfolio you are free to create a body of work of your choice. You may build off of one of the previous two portfolios, or follow a completely new path. You will still need to complete the portfolio proposal and then produce a portfolio of 10-12 images conceptually related to your chosen themes.
